## Introduction

The Inter American Accreditation Cooperation (IAAC) is a regional organization that works through the joint efforts of organizations and professionals in the areas of accreditation and conformity assessment. IAAC coordinates its activities through the "2021-2026 IAAC Strategic Plan". This plan defines the objectives, goals, actions and responsibilities.

This Strategic Plan is based on the vision, mission, policies, objectives and documents of the of the IAAC Quality Management System, which are aligned with the ILAC and IAF requirements and documents.

## 2021-2026 Strategic Goals

## The IAAC has five principal goals as described below:

- To maintain, improve and expand the scopes of the IAAC MLA. and maintain international recognition as a Regional Cooperation by IAF and ILAC
- 2. To strengthen relationships at the international and regional level
- 3. To increase technical competence of members
- 4. To achieve and maintain economic/financial sustainability
- 5. To improve the efficiency of IAAC to strengthen its leadership

In the achievement of these five overarching goals, the following specific actions will be undertaken:

- a) To facilitate commercial exchange among the nations or bloc of nations of the Americas through a system of accredited conformity assessment bodies;
- b) To develop, maintain, improve and extend the scopes of the IAAC Multilateral Recognition Arrangements;
- c) To maintain status as a Regional Cooperation recognized by the International Accreditation Forum (IAF) and the International Laboratory Accreditation Cooperation (ILAC), or by the international accreditation organization(s) that may replace them;
- d) To promote acceptance of accreditations granted by its accreditation member bodies, based on equivalence of operation of their accreditation system and their respective schemes, within the international accreditation framework, and in cooperation with other



- regional groups of accreditation bodies, as well as to promote international acceptance of results issued by duly accredited conformity assessment bodies;
- e) To promote the transfer of knowledge and technical information, sharing of information, visits by regional experts, and similar activities to assist new, developing and established accreditation schemes:
- f) To facilitate collaboration, cooperation and mutual assistance among members;
- g) To assist the current and potential IAAC members, on matters related to accreditation of conformity assessment bodies;
- h) To harmonize the criteria for the operation of member accreditation bodies, based on relevant ISO/IEC international standards and guides and IAF and ILAC documents;
- i) To facilitate the exchange of information between and among accreditation body members of IAAC and members of IAF and ILAC;
- j) To promote cooperation in training of peer evaluators and personnel of accreditation bodies:
- k) To facilitate the adoption and implementation of standards, guidelines and application of documents developed by relevant international bodies;
- To encourage and support the development of accreditation bodies in the countries of the Americas;
- m) To work with other relevant regional bodies in the Americas such as Pan American Standards Commission (COPANT), the Inter American Metrology System (SIM), and the regional accreditation cooperation bodies as well as with other relevant organizations to promote the regional Quality Infrastructure; and
- n) To seek financial and institutional support from regional and international organizations to support IAAC and its members in the areas of accreditation and conformity assessment
