#### **Digitization**

process of converting information into a digital (i.e. computer-readable) format.

#### **Digitalization**

turning interactions, communications, business functions and business models into (more) digital ones.

#### **Digital Transformation**

a profound and accelerating transformation of business activities, processes, competencies, and models to fully leverage the changes and opportunities of digital technologies.

#### Self-assessment of requirements

- Identify processes like application, scheduling, planning, delivery, reporting, decisions, complaints, appeals, scheme management, accounts payable, accounts receivables, internal controls
- Governance, risk & compliance
- Resource management
- Data management







#### Self-assessment of requirements

- Describe digital process flow for each process, capturing date & time, geotagging
- Format for displaying data
- Access permissions to users within and outside the AB, team confirmation, assessment components like opening meeting & closing meeting attendance
- Checklist, scope of Accreditation, NC, observations, review of RCA & CA, etc.







#### Self-assessment of requirements

- Decision making process, communication with CAB & assessment team
- Issue of accreditation certificate, feedback & monitoring of assessors
- Appeal process flow, complaint process flow and communications
- Other activities like scope extension, premises change, etc.







#### Mobile app-based assessments

- Customized app by AB for lab and site use.
- Prefilled checklists for tests/calibrations.
- Equipment linked with test / calibration (gets automatically fetched).







#### Mobile app-based assessments

- Geo-tagged selfies for assessment team.
- Prefilled team details for meetings.
- Prefilled checklist for Team Leader as well as team member (clauses of ISO 15189 or ISO/IEC 17025, etc.).







#### Mobile app-based assessments

- Select witnesses and assessment techniques.
- Editable scope and manage non-conformities.
- Sync data after assessment, offline entry available.
- No CAB visible before and after assessment dates.







### Unified dashboard for CABs, AB and Regulators

- Availability of CAB reports for Regulators, ABs
- Authentication through single window creates trust
- Time efficient avoids duplicity of effort
- · Facilitates seamless trade in domestic and global markets







### Unified dashboard for CABs, AB and Regulators

- Single window for exploring regulators' requirements
- Single window to identify CABs having specific capabilities
- Data Analysis







### Unified dashboard for CABs, AB and Regulators

- Benefit for exporters as well as importers
- Ease in tracking reports under Rapid Alerts / RASFF
- Real time tracking of ongoing samples of market surveillance / regulators







### Using reconstructed data smartly

- Data analysis for ease of users
- Trends in sectors of CABs
- Identifying capabilities in various sectors like finer CMCs, Extra HV capabilities, etc.
- Trends in CAB applications and response of AB in specific sectors like construction, energy, telecom, etc.







### Using reconstructed data smartly

- Identifying areas where assessors are to be developed
- Trend of applications received over various months in a Financial Year
- Pattern of emerging area applications of CABs in the various parts of the country
- Export specific / regulator specific CAB identification







### Using reconstructed data smartly

- Monitoring of CAB assessment programme
- Continuity in accreditation and maturity of CABs
- Continuous compliance monitoring of CABs since first accreditation
- Trends in NCs helps in harmonization of assessors and sensitization of CABs
